

KNOW ALL MEN BY THESE PRESENTS, that **PIEDMONT HOLDINGS, INC.**



McWHITE and BETTY JO McWHITE**, their heirs and assigns forever,

ALL that lot of land on the southeastern side of Mustang Circle in Austin Township, Greenville County, South Carolina, being shown as Lot No. 14 on a Plat of the Subdivision of S. I. RANCHETTES made by Dalton & Neves, Engineers, dated April, 1965, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book JJJ, Page 31, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Mustang Circle at the joint front corners of Lots Nos. 13 and 14 and running thence along said side of Mustang Circle N. 70-26 E. 110 feet to an iron pin; thence continuing along said side of Mustang Circle N. 63-35 E. 120 feet to an iron pin; thence S. 43-39 E. 403.8 feet to an iron pin; thence S. 62-06 W. 200 feet to an iron pin; thence S. 74-51 W. 140 feet to an iron pin; thence N. 27-12 W. 380.7 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to the building set back line shown on the recorded Plat and to Protective Covenants applicable to S.I. Ranchettes Lots Nos. 11 through 28 and Lot No. 1 which appear of public record in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 778, Page 249.
