I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Polly P. Crisp and P. D. Forrest, Jr.

on or about the \_\_\_\_\_ day of July \_\_\_\_\_ in the year of  
our Lord nineteen hundred and Sixty Five \_\_\_\_\_ exhibited their  
complaint in the Court of Common Pleas \_\_\_\_\_ for the County aforesaid, against  
Barbara Jane Forrest and Daniel Bedford Forrest

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard  
on the 24th day of September 19 65,  
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and  
decree that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for  
the County aforesaid, to Polly P. Crisp

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;  
(See Judgment Roll No. J-5175.)

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of  
Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto  
the said Polly P. Crisp, all the right, title and interest of Barbara  
Jane Forrest and Daniel Bedford Forrest in and to the following des-  
cribed real estate:

Tract No. 3.

"ALL that certain piece, parcel or tract of land, situate, lying and  
being in the County of Greenville, State of South Carolina, containing  
9 acres, more or less, and having the following metes and bounds,  
according to a plat thereof made by J. C. Hill, under date of August 7,  
1965, recorded in Plat Book KKK, page 141; to wit:

"BEGINNING at an iron pin, 395 feet S. 7-30 E. from stone corner of  
Howard property, which pin is at the southwest corner of the tract of  
land being conveyed to Daniel Bedford Forrest, and running thence S. 7-30  
E. 263 feet, more or less, to center of Geer Highway #276; thence with  
the center of said Highway: S. 88-00 E. 100 feet; S. 85-20 E. 100 feet;  
S. 77-10 E. 100 feet; S. 69-15 E. 100 feet; S. 61-10 E. 100 feet;  
S. 54-50 E. 100 feet; S. 53-30 E. 84.1 feet to the center of the inter-  
section of said Highway and Jones Gap Road (now River Falls Road); thence  
leaving said Highway and following the center of said Road: N. 33-00 E.  
525 feet; N. 10-00 E. 101 feet; N. 9-40 W. 132 feet to corner of said  
land being conveyed to Daniel Bedford Forrest; thence with line of said  
Forrest land S. 77-45 W. 971 feet to the beginning corner."

This deed is made pursuant to the Order of Court and is for the  
partition of land by and between the plaintiffs and defendants and is  
without any monetary consideration and, for that reason, it is not  
necessary to place any revenue stamps on the Master's deed.
