the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. A. Moore, His Heirs and Assigns:

All that piece, parcel of lot of land located, situated and being in Greenville County, State of South Carolina, known as Lot No. 55 in a subdivision known as Edwards Forest, Section 2, near Taylors, South Carolina, the same being shown on a plat of same by Dalton & Neves, dated March, 1957, said plat being recorded in RMC Office Greenville County in Plat Book RR, page 20, revised April 6, 1964 and recorded in Plat Book RR, Page 20, and having according to said plat the following metes and bounds:

BEGINNING at iron pin on the north side of Wayne Drive at the joint front corner of Lots 55 and 56 and running thence with the line of said lots S. 33-15 E. 198.6 feet to iron pin on Casselwood Street thence with Casselwood Street S. 84-21 W. 99.8 feet to bend; thence continuing with Casselwood Street S. 66-45 W. 42.1 feet to curve at the intersection of Casselwood Street and Randy Drive; thence with said curve, the chord of which is, N. 67-54 W. 33.2 feet to a point on Randy Drive; thence with Randy Drive N. 32-32 W. 93.4 feet to curve at the intersection of Randy Drive and Wayne Drive; thence with said curve, the chord of which is, N. 17-08 E. 38.5 feet to a point on Wayne Drive; thence with Wayne Drive N. 56-45 E. 103.1 feet to point of beginning.
