All that piece, parcel or lot of land located, situated and being in Greenville County, State of South Carolina, known as Lot No. 90 on Randy Drive, in a subdivision known as Edwards Forest, Section 2, near Taylors, South Carolina, the same being shown on a plat of same by Dalton & Neves, dated March, 1957, said plat being recorded in RMC Office Greenville County in Plat Book RR, page 20, revised April 6, 1964 and recorded in Plat Book RR, Page 20, and having according to said plat the following metes and bounds:
