the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **O. B. GODFREY, his heirs and assigns :**

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, situate on the eastern side of LEACROFT DRIVE, near the City of Greenville, being shown as lot No. 31 on a plat of SECTION II of SPRING FOREST, recorded in the RMC office for Greenville County in Plat Book BBB, Page 34, and described as follows:

BEGINNING at an iron pin on the southeastern corner of Leacroft Drive and Ayrshire Drive, and running thence with the eastern side of Leacroft Drive S. 23-30 E. 101.45 feet to iron pin at corner of Lot 30; thence with line of said lot N. 62-30 E. 140 feet to iron pin at corner of Lot 32; thence with line of said lot N. 23-30 W. 135 feet to iron pin on Ayrshire Drive; thence with the southern side of said Drive S. 66-30 W. 50 feet and S. 62-30 W. 65.3 feet to iron pin at corner of Leacroft Drive; thence with the curve of the intersection, the chord of which is S. 16-49 W. 38.2 feet to the beginning corner.

This lot is conveyed subject to restrictions recorded in Deed Book 772 at Page 225, and subject to the drainage easement across the rear of said lot, as shown on said plat.
