the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Billy W. Brewer and Mary E. Brewer, Their Heirs and Assigns, Forever:

ALL that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, known and designated as Lot No. 48 on the north-easterly side of Gardenia Drive as shown on a plat of Cedar Lane Gardens, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG, page 139, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Gardenia Drive, at the joint front corner of Lots Nos. 47 and 48, and running thence along the joint line of said lots N. 37-01 E. 128.4 feet to an iron pin in the center of a 10 ft. drainage easement, rear line of Lot No. 38; thence along the center of said easement and a portion of Lot No. 38 N. 43-11 W. 80 feet to an iron pin in rear line of Lot No. 37, joint rear corner of Lots Nos. 48 and 49; thence along the joint line of said lots S. 39-21 W. 147.5 feet to a point on the northeasterly side of Gardenia Drive; thence along the northeasterly side of Gardenia Drive N. 56-33 E. 85 feet to the point of beginning.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
