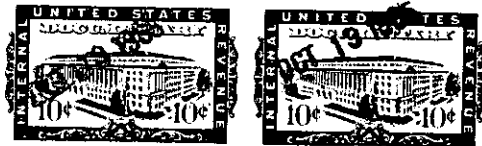
KNOW ALL MEN BY THESE PRESENTS, that I, Joe Murphree, of Greenville County,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Shubuta Drive, being shown as Lot No. 76 on a plat of Farmington Acres recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 106 and 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Shubuta Drive at the joint front corner of Lots 76 and 77, and running thence with common line of said lots, N. 37-45 W. 150 feet to an iron pin; thence N. 52-45 E. 90 feet to an iron pin; thence S. 37-45 E. 150 feet to an iron pin on the northwestern side of Shubuta Drive; thence with the northwestern side of said drive, S. 52-45 W. 90 feet to the beginning corner; being the same conveyed to me by Talley Realty, Inc. by deed dated June 11, 1965 and recorded in the R.
