in consideration of Seven Hundred Fifty and no/100 (\$750.00)----- Dollars,

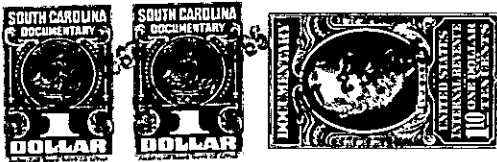

ALL that piece, parcel or tract of land in Oneal Township, Greenville County, State of South Carolina, situate, lying and being about one-half (1/2) mile southwest from Milford Baptist Church containing 2.5 acres and being more particularly described according to a plat of survey by C. C. Jones, Civil Engineer, dated February 1965, as follows:

BEGINNING at a point in the center of a County road at the corner of other property of the Grantor herein and running thence S. 19-27 W. 300 feet to an iron pin in the line of property of E. R. Taylor; thence along Taylor line S. 75-30 E. 389.2 feet to an iron pin in the line of the property of E. R. Taylor, Jr; thence along the line of said property of E.R. Taylor, N. 7-19 E. 316 feet to a point in the center of the aforesaid County road; thence along the center of the said County road and following the curvature thereof, the chords being N. 77-41 W. 270 feet and N. 71-03 W. 55 feet, to the beginning corner.
