the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release WALTER RALEIGH MCLAWHORN, His Heirs and Assigns Forever

All those lots of land in the State of South Carolina, County of Greenville, near the Town of Fountain Inn, being designated as Lots 1,2, and 3 on a plat of the S.L. Coleman Estate prepared by J.D. Calmes, Surveyor, in October, 1960, said lots being described as a whole according to said plat as follows:

BEGINNING At a point on the northern side of S.C. Highway 418 at the joint corner with a lot previously conveyed to Fountain Inn Properties by deed recorded in Deed Book 610 at page 458 and running thence along the line of said lot, N. 8-40 E. 172.4 feet to a point on the southern line of Westerly Heights Subdivision; Thence along the line of said Subdivision, N. 85-15 E. 356.9 feet; Thence S. 3-50 W. 249.7 feet to a point on the northern side of S.C. Highway 418; Thence along said Highway N. 82-23 W. 366.4 feet to the point of beginning. This is a portion of the 8.81 acre tract which was conveyed to the late S.L. Coleman by deed recorded in Deed Book 271 at page 172. Said tract was subsequently devised to the grantors by the said S.L. Coleman as will appear by reference to Apartment 472 file  $\bar{1}$  in the Greenville County Probate Court. It is the intent of the grantors to convey all that portion of said 8.81 acre tract as lies north of said Highway 418, the foregoing description notwithstanding.

In the aforementioned deed recorded in Deed Book 610 at page 458 it was recited that the lot conveyed therein was adjacent to property "conveyed to Greenville County for street purposes" which street would have run: along the western side of the lot conveyed herein. The grantors herein hereby warrant and represent that said property was in fact never deeded to said County and no such street was ever opened although at that time such action was being contemplated.
