That I, Gerda Luyties Prevost in the State aforesaid, in consideration of the sum of One and No/100ths (\$1.00) - - - - - DOLLARS, and love and affection to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Christie C. Prevost, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of S. C., on the Southern side of Brookside Way in a sub-division known as Marshall Forest, a plat of said sub-division being recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book H at pages 133-134, and being described according to a more recent plat prepared by J. C. Hill, Surveyor, dated August 10, 1954 entitled "Property of C. C. Prevost, Marshall Forest, Greenville, S. C.", and having according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Southern side of Brookside Way at the joint corner of the within conveyed premises and property of the grantee, and running thence along the common line of said properties S. 29-44 E. 195.4 feet to an iron pin; thence S. 66-35 W. 57.5 feet to an iron pin; thence N. 15-05 W. 193.4 feet to an iron pin on the Southern side of Brookside Way; thence along the Southern side of Brookside Way N. 61-77 E. 10 feet to an iron pin at the beginning corner.

The above described property is a portion of the property conveyed to the grantor herein by Gerda Prevost (now Gerda Prevost McCahan) by deed dated April 11, 1949 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 379 at page 62. The subject premises are also shown on Greenville County Block Book Sheet 210, Block 4, as a portion of Lot No. 3.
