release unto William H. and Doris K. Chapman

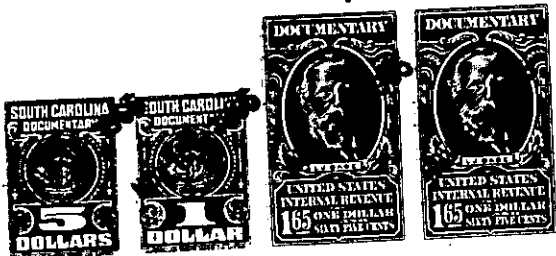
