in consideration of Seven Hundred Twenty-Five (\$725.00) - - - - - Dollars,

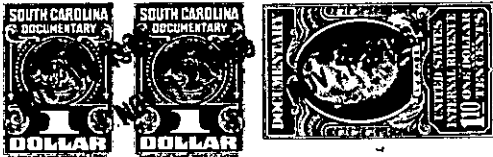
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

BEGINNING at a large poplar on bank of Devil's Fork Creek, and running thence, N 24-50 W, 288 feet to an iron pin (crossing Devil's Fork Road); thence re-crossing said road, S 36-40 W, 600 feet to an iron pin in old line; thence S 49-30 E, 172 feet past an iron pin on bank to the center of the aforementioned creek; thence up said creek, 500 feet, more or less, to the beginning corner, containing three (3) acres, more or less.
