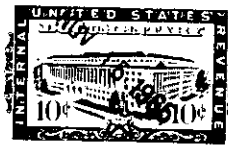

KNOW ALL MEN BY THESE PRESENTS, that **HATTIE T. PRESSLEY, LARRY L. PRESSLEY, ALLAN T. PRESSLEY AND OLIN K. PRESSLEY**

in consideration of Nine Thousand and No/100 ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **HERBERT M. MULL AND HARVEY C. WATSON, their heirs and assigns forever,**

ALL of that tract of land in the County of Greenville, State of South Carolina containing five (5) acres more or less and being a portion of Lots 29, 30 and 31 of the Subdivision of Riverside Farms as shown in Plat Book K at Page 100 and being further shown on a plat entitled "Property of K. E. Pressley" dated May 20, 1937 by C. M. Hunter and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Edgemont Avenue at the joint front corner of Lots Nos. 30 and 31 and running thence along Edgemont Avenue S 63-45 E, 75 feet to an iron pin; thence along the property of Larry Pressley, now or formerly, N 25-15 E, 150 feet to an iron pin; thence S 63-45 E, 75 feet to an iron pin; thence N 25-15 E, 310 feet to an iron pin; thence along the rear lines of Lots 36 and 37, N 53-15 W, 450 feet to an iron pin; thence S 29-10 W, 546 feet to an iron pin on the northern side of Edgemont Avenue; thence S 58-30 E, 65 feet to an iron pin; thence with said avenue S 63-45 E, 250 feet to the point of beginning.

THIS is the same property conveyed to K. E. and Hattie Pressley in Deed Book 182 at Page 258. K. E. Pressley died intestate as will appear by reference to Apartment 658, File 18, leaving as the sole heirs and distributees, his widow, Hattie T. Pressley and three, (3) sons, shown as the other grantors.
