G. Singleton, his heirs and assigns forever:

"All that piece, parcel or lot of land situate, lying and being in Cleveland Township, Greenville County, State of South Carolina, on the southwestern side of Echo Drive on Caesar's Head Mountain, being shown as Lot No. 61 of Section A on plat of Paris Mountain - Caesar's Head Company recorded in the R. M. C. Office for Greenville County in Plat Book G, page 122, and described as follows:

"BEGINNING at an iron pin on the southwest side of Echo Drive at the corner of Lot No. 59 formerly owned by C. B.
