the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Levis L. Gilstrap, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the northeastern side of Hampton Court and being known and designated as a portion of Lot No. 13 on a plat of Section 2 of Wade Hampton Gardens recorded in Plat Book "DDD", at Page 54 and having, according to a more recent survey by H. C. Clarkson, Jr. dated October 22, 1965, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Hampton Court at the joint front corner of Lots Nos. 12 and 13 and running thence along the joint line of said lots N. 73-51 E. 71.4 feet to an iron pin at the corner of a triangle this date conveyed by the grantee to the grantor; thence with a new line through Lot No. 13 S. 58-45 W. 69.85 feet to an iron pin; thence along the northeastern side of Hampton Court N. 27-57 W. 19 feet to the point of beginning.
