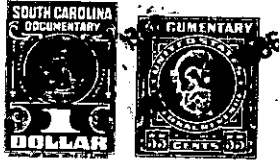

KNOW ALL MEN BY THESE PRESENTS, that I, Levis L. Gilstrap

in consideration of Five hundred and no/100 -----Dollars,  
(and assumption of mortgage)  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Darrell F. Case

All that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number III of a subdivision known as McSwain Gardens, Section 2, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book LL at Page 137, and having the following metes and bounds, to wit:

BEGINNING at a point on the Western side of Beaufort Street at the joint front corner of Lots 110 and 111 and running thence N. 83-55 W. 175 feet to a point at the joint rear corner of Lots 110 and 111; thence N. 06-05 E. 143 feet to a point; thence N. 64-19 E 116 feet to a point at the joint rear corner of Lots 111 and 112; thence S 25-41 E. 154.4 feet to a point on the Northwestern side of Beaufort Street at the joint front corner of Lots 111 and 112; thence following the curvature of the Northwestern side of Beaufort Street S 33-05 W. 33.6 feet to a point; thence following the curvature of the Western side of Beaufort Street S.12-47 E. 39.4 feet to the point of beginning.

This Deed is executed subject to existing and recorded restrictions and rights of way.

The Grantee agrees to assume and pay the mortgage given by the Grantor to First Federal Savings and Loan Association in the original amount of \$18,000.00. This mortgage is being recorded in Book of Mortgage 1009, at Page 527

This is the same property conveyed to Grantor by deed recorded in the Greenville County R. M. C. Office, in Deed Book 713 at Page 319

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
