KNOW ALL MEN BY THESE PRESENTS, that I, Leon Stark,

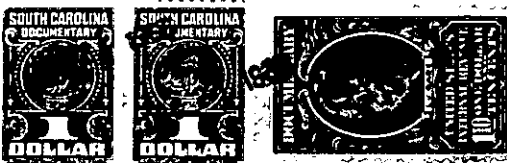
in consideration of Six Hundred and No/100 (\$600.00)----- Dollars,
and assumption of mortgage
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Cecil D. Buchanan, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the southeastern side of Dakota Avenue (formerly Parkins Mill Road) and on the northeastern side of Service Drive and being known and designated as Lot No. 2 on plat of Property of George N. and Eleanor G. Beattie as shown on plat prepared by Piedmont Engineering Service dated June 27, 1949 recorded in Plat Book "V", at Page 193 and having, according to a more recent survey by R. W. Dalton dated January 1956, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Dakota Avenue at the joint front corner of Lots Nos. 1 and 2 and running thence along the line of Lot No. 1 S. 50-47 E. 141.4 feet to an iron pin; thence with the line of Lot No. 3 S. 37-55 W. 66 feet to an iron pin; on the east side of Service Drive; thence along Service Drive N. 50-22 W. 108.6 feet to an iron pin; thence with the curve of said intersection, the chord of which is N. 9-42 W., 37.9 feet to an iron pin; thence along the southeastern side of Dakota Avenue N. 30-59 E. 40.6 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 544, at Page 145.

As part of the consideration for the within conveyance the grantee assumes and agrees to pay the balance due on the mortgage over the above property to C. Douglas Wilson & Co. recorded in Mortgage Book 666, at Page 325, which balance is presently \$3,645.46 with interest paid to December 1, 1965.
