KNOW ALL MEN BY THESE PRESENTS, that I, Douglas D. Gleason

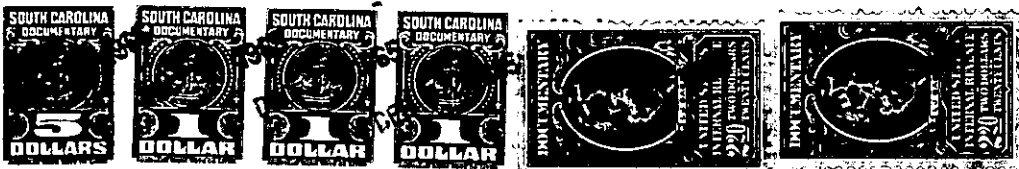
in consideration of Four Thousand and no/100 ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Levis L. Gilstrap

All that piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 43 Section 3, of a subdivision known as Lockwood Heights as shown on plat of property of Lula B. Thruston prepared by C. C. Jones, Engineer, recorded in the R. M. C. Office for Greenville County in Plat Book XX, at page 11, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Blue Mist Drive, joint front corner of Lots Nos. 42 and 43, and running thence with the joint line of said lots, S. 61-30 W. 174 feet to an iron pin; thence S. 28-30 E. 84 feet to an iron pin in the rear line of Lot No. 45; thence with the rear line of Lot No. 45, N. 68-43 E. 70.3 feet to an iron pin at the rear corner of Lot No. 44 thence with the rear line of Lot No. 44, N. 65-34 E. 99.3 feet to an iron pin on the Western side of Blue Mist Drive; thence along the Western side of Blue Mist Drive, N. 22-00 W. 25 feet to an iron pin; thence continuing with said drive, N. 25-15 W. 59.9 feet to an iron pin; thence continuing with said drive, N. 28-30 W. 15 feet to the beginning corner.

This is the same property conveyed to grantor by deed recorded in the Greenville R. M. C. office in Deed Book 705 at page 443.

The Grantee assumes and agrees to pay a balance on mortgage given to First Federal Savings and Loan Association, being recorded in the Greenville County R. M. C. Office, in Mortgage Book 900, at Page 7, and having a present balance of \$9,811.55.
