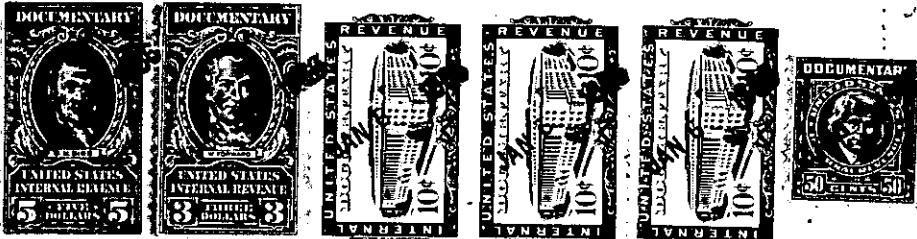

C., his successors and assigns, in fee simple, all that lot or parcel of land situate, lying and being in the County of Greenville, State of South Carolina, and more particularly described as follows:

All that lot of land in the city of Greenville, County of Greenville, State of South Carolina, on the southeast side of Glenn Road, being known and designated as Lot No. 1 on plat of property of J. W. Cannon, Inc., recorded in plat book PP page 111 of the RMC Office for Greenville, County, and being a portion of lot No. 16, Block B, on plat of Glenn Farms recorded in plat book M, page 75 of the RMC Office for Greenville County.



Being the same property conveyed to the Metropolitan Life Insurance Company by Master's Deed dated December 9, 1965 and recorded December 13, 1965, in Book 788 Page 110 Greenville County, S. C., and recorded in Master's Title Book Page

TOGETHER with all and singular the hereditaments, rights, members and appurtenances whatsoever to the said lot or tract of land belonging, or in any wise incident or appertaining, and the revisions and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD the said lot or parcel of ground and premises above described and mentioned, and hereby intended to be conveyed, together with the rights, privileges, appurtenances and advantages thereto belonging or appertaining, unto and to the proper use of the said Federal Housing Commissioner, his successors and assigns, in fee simple.

AND the said METROPOLITAN LIFE INSURANCE COMPANY hereby covenants that it will warrant specially the property herein conveyed as to any acts done by it that would affect or impair the title of the said property and that it has not done or suffered to be done any act, matter, or thing whatsoever, to encumber the property hereby conveyed.
