KNOW ALL MEN BY THESE PRESENTS, that I, Lloyd W. Gilstrap,

in consideration of Sixty Four Hundred Seventy One and 16/100 (\$6471.16)----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. C. Paddie, his heirs and assigns forever:

All that piece, parcel or lots of land situate, lying and being in the County of Greenville, State of South Carolina, at Greer, on the northern side of Brown Street Extension and being known and designated as Lots Nos. 6 and 7 on plat of property of Juanita Rodgers recorded in the R. M. C. Office for Greenville County in Plat Book "Q", at Page 161 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Brown Street Extension at the joint front corner of Lots Nos. 7 and 8 and running thence along the northern side of said Street S. 73-45 W. 126 feet to and iron pin; thence N. 12-20 W. 160 feet to an iron pin; thence N. 73-45 E. 31.5 feet to an iron pin at end of Alley; thence S. 12-20 E. 7.5 feet to an iron pin; thence along the south side of said Alley N. 73-45 E. 94.5 feet to an iron pin at the joint rear corner of Lots Nos. 7 and 8; thence along the joint line of said lots S. 12-20 E. 152.5 feet to the point of beginning.
