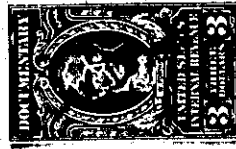

KNOW ALL MEN BY THESE PRESENTS, that I, W. Allen Reese

in consideration of Five Thousand Four Hundred Seventy-five and No/100 (\$5,475.00) Dollars,  
and assumption of Grantor's indebtedness on the mortgage set forth below;  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto James A. Boling, his heirs and assigns forever:

All of my right title and interest in and to the following described property:

ALL that lot of land in the Town of Fountain Inn, County of Greenville, State of South Carolina on the Western side of South Main Street, being known as a portion of Lot No. 3 and a portion of Lot No. 4 in accordance with a plat made by T. C. Adams on December 14, 1955 and being recorded in the R. M. C. Office for Greenville County in Plat Book JJ, at Page 85, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Main Street at the corner of property of Knight and Weathers, which iron pin is situate 193.66 feet North-west of the intersection of Main Street and Case Street, and running thence along the line of property of Knight and Weathers S. 54-28 W. 47.2 feet to an iron pin on the C & G Railroad right-of-way; thence with said right-of-way N. 43-33 W. 20.4 feet to an iron pin on said right-of-way at the corner of property owned by Stewart; thence along the Stewart property, N. 54-02 E. 50.2 feet to an iron pin on the Southwestern side of Main Street; thence with Main Street, S. 35-58 E. 20.5 feet to the point of beginning.

ALSO: All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being on the Southern side of East North Street, between Broadus Avenue and Manly Street, and being known as a portion of Lot 2, Block 5, of Boyce Addition, according to plat recorded in the R.M.C. Office for Greenville County in Deed Book ZZ, at Page 934, and having, according to a more recent survey entitled Property of Chas. W. Spence, Melvin K. Younts & James A. Boling, recorded in the R. M. C. Office for Greenville County in Plat Book HHH, at Page 93 the following metes and bounds:

BEGINNING at an iron pin on the Southern side of East North Street, which iron pin is situate 143.1 feet East of the intersection of Broadus Avenue, and running thence S. 16-07 E. 170.3 feet to an iron pin on the Northern side of a 15-foot public alley; thence with said alley, N. 76-0 E. 35 feet;

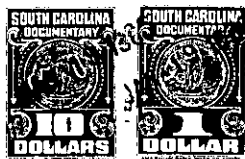
