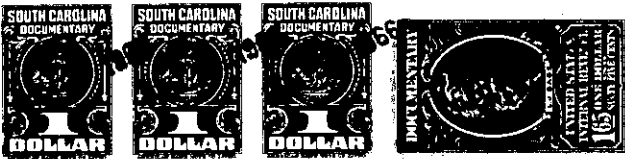
JOHNNY SIZEMORE and GLORIA JEAN SIZEMORE, their heirs and assigns,

ALL that piece, parcel or lot of land on the northern side of Blossom Drive, in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 8 on a Plat of Kennedy Park, made by Piedmont Engineers and Architects, dated September 28, 1964, as revised, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book JJJ, Page 44, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Blossom Drive at the joint front corners of Lots Nos. 9 and 10; and thence running along the common line of said lots N. 2-42 E. 130.2 feet to an iron pin; thence N. 87-37 W. 75 feet to an iron pin; thence S. 2-42 W. 130 feet to an iron pin on Blossom Drive; thence along the northern side of Blossom Drive S. 87-18 E. 75 feet to an iron pin, the beginning corner.

The above described property is the same conveyed to the Grantors herein by Deed of Henry C. Harding Builders, Inc., recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 788, Page 90, and is hereby conveyed subject to easements and building restrictions of public record.

As part of the consideration for this Deed, the Grantees assume and agree to pay in full the indebtedness covering the above described property on a note and mortgage in favor of Fountain Inn Federal Savings & Loan Association, recorded in the R.M.C. Office for Greenville County, South Carolina, in Mortgage Book 1016, Page 487, which has a present balance due in the sum of \$ 9,200.00.
