KNOW ALL MEN BY THESE PRESENTS, that I, Elizabeth D. Slatton in the State and County aforesaid

in consideration of Love and Affection and Ten and No/100

Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alvin H. Dill and his heirs and assigns all that piece, parcel or lot of land in Highland Township, Greenville County and State of South Carolina, located about one mile east of Camp Creek Church at the intersection of the Bramlett Road (or Packs Mountain Road) and the Camp Creek-Tigerville Road. This lot of land is bounded by lands of H. Beacham on the south and west, Kenneth and Martha Lou Waters on the North and land of Robert Anderson on the East; and having the following courses and distances To Wit:

BEGINNING on an iron pin at the intersection of the Camp Creek-Tigerville Road and the Bramlett Road and runs thence in a southward direction 141 feet to an iron pin on the bank of the Bramlett Road; thence in an eastward direction with said road 214 feet, more or less to an iron pin in the center of the road; thence in a northward direction 175 feet, more or less, to an iron pin in center of Camp Creek-Tigerville Road; thence westward 205 feet, more or less, to an iron pin at the intersection of said roads, the beginning corner, and containing 76/100 of an acre, more or less. This is the same lot of land conveyed to me by T. M. Dill by Deed dated August 3, 1957 A.D. and recorded in the Office of Register of Mesne Conveyance for Greenville County in Book Q of Deeds, page 641.
