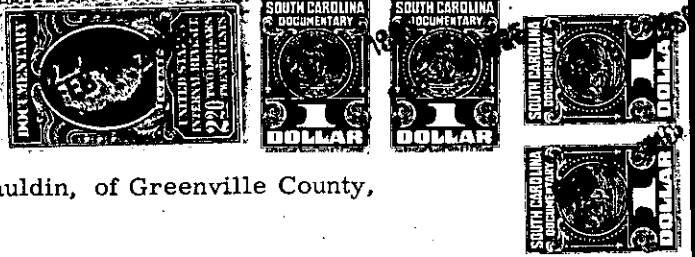

and assumption of mortgage set out below  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Rabon Hugh Edmonds and Rose Ann M. Edmonds, their heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 44 of an Extension of Section One of a subdivision known as Brookwood Forest as shown on a plat thereof prepared by C. C. Jones, C. E., February 13, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX at Page 96, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Charing Cross Road, joint front corner of Lots Nos. 43 and 44 and running thence along the western side of Charing Cross Road, N. 7-04 E. 62 feet to an iron pin; thence continuing along the western side of Charing Cross Road, N. 12-25 E. 62.8 feet to an iron pin at the joint front corner of Lots Nos. 44 and 45; thence along the joint line of said lots, N. 76-35 W. 130 feet to an iron pin; thence S. 8-10 W. 140.3 feet to an iron pin at the rear corner of Lot No. 43; thence along the line of that lot, S. 83-45 E. 126 feet to the beginning corner.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.

As a part of the consideration for this conveyance, the grantees expressly assume and agree to pay the balance due on that certain note and mortgage, in the original sum of \$9,700.00 executed by the grantor to the First Federal Savings and Loan Association of Greenville and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1022 at Page 64, the balance due thereon being the sum of \$9,700.00 as of this date.
