All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina on the western side of Scarlett Street and being known and designated as Lot No. 217-A on plat of Sherwood Forest Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "GG", Pages 70 and 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Scarlett Street, joint front corner of Lots Nos. 217 and 217-A and running thence along the common line of said lots S. 83-02 W. 170 feet to an iron pin; thence across the rear line of Lot No. 217-A S. 6-58 E. 75 feet to an iron pin; thence with the common line of Lots Nos. 215 and 217-A N. 83-02 E. 168.2 feet to an iron pin on the western side of Scarlett Street; thence with the western side of said Street the following metes and bounds: N. 2-50 W. 22.9 feet to an iron pin, N. 6-58 W. 52.2 feet.
