KNOW ALL MEN BY THESE PRESENTS, that We, Louise H. Carlisle and R. C. Carlisle

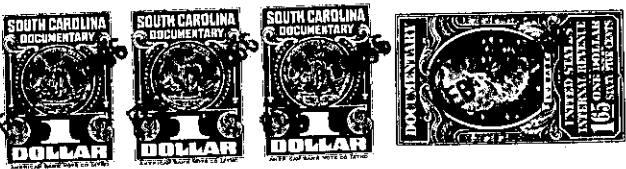
