the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Larry E. Shirley, Jr, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 36 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R.M.C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Salem Court at the joint front corner of Lots 35 and 36 and running thence with the Southeastern side of Salem Court S 34-52 W 70 feet to a point; thence following the curvature of the Southeastern intersection of Salem Court with Penarth Street (the chord of which is S 1-52 W 84 feet) to a point; thence with the Northeastern side of Penarth Street S 31-07 E 161 feet to a point; thence N 65-13 E 72.5 feet to a point; thence N 20-55 E 147.6 feet to a point at the joint rear corner of Lots 35 and 36; thence N 55-08 W 190.9 feet to the point of beginning.
