That I, WILLA MARTIN PIERCE in the State aforesaid, in consideration of the sum of TEN AND NO/100 (\$10.00) and other consideration to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Louisa M. Redfearn, her Heirs and Assigns, forever:

An undivided one-fourth interest in and to all that certain piece, parcel and lot of land lying and being situate on the corner of East Washington and Spring Street in the City of Greenville, County and State aforesaid, said lot being known and designated as Lot No. 6 upon a plat recorded in the Office of RMC for Greenville County in Plat Book C, page 59, and being the same lot conveyed to C. B. Martin by J. W. Norwood by his deed dated December 23, 1919 and recorded in the RMC Office for Greenville County in Book 66, page 60, and having the following courses and distances as shown on said plat and as mentioned in said deeds:

BEGINNING at an iron pipe at South-west corner of East Washington Street & Spring Street and running thence with East Washington Street N 69-30 W, 50 feet to an iron pin; thence S 22-42 W, 100.12 feet to an iron pin on alley; thence along the North side of said alley S 69-39 E, 50 feet to an iron pin on Spring Street; thence with Spring Street N 22-42 E, 100.12 feet to the beginning corner.

The interest herein conveyed was conveyed to me by deed of Patricia Martin Starmont, dated June 24, 1965, recorded in the RMC Office for Greenville Co., S.C., in Deed Book 777, page 24.

The Grantor also acquired a one-fourth (1/4) interest in the above property under deed from Willie H. Martin dated June 29, 1951, recorded in the RMC Office for Greenville Co., S.C., in Deed Book 437, page 233, but that one-fourth (1/4) interest is being retained by the Grantor and not conveyed by this deed.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

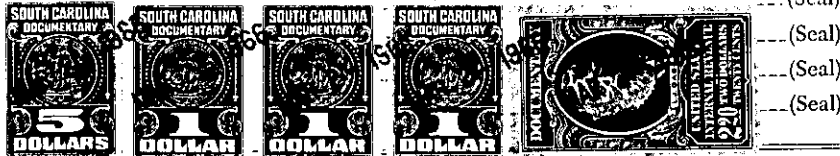
