KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County,

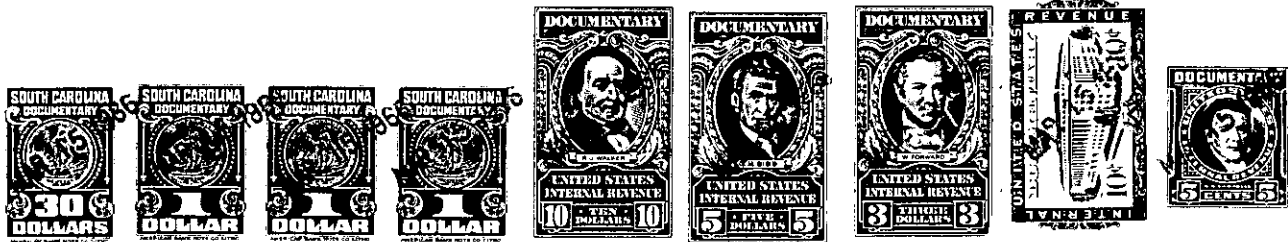
in consideration of Sixteen Thousand, Five Hundred and No/100-----(\$ 16,500.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles L. Sutton and Ida Jane B. Sutton, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 10 of a subdivision known as Colonial Hills, Section No. 3, as shown on a plat thereof prepared by Piedmont Engineers & Architects, dated May 7, 1965, recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Creighton Street, joint front corner of Lots 9 and 10, and running thence with the joint line of said lots, N. 80-15 W. 150 feet to an iron pin; thence S. 9-45 W. 100 feet to an iron pin, joint rear corner of Lots 11 and 10; thence with the joint line of said lots, S. 80-15 E. 150 feet to an iron pin on the western side of Creighton Street; thence with said street, N. 9-45 E. 100 feet to the beginning corner; being the same conveyed to me by Williams Land Co., same as Williams Land Company, Inc., by deed dated August 3, 1965, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 779, at Page 510.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
