Lindsey Builders, Inc., its successors and assigns forever:

All that certain piece, parcel or lot of land, lying and being on the southerly side of Patti Drive, near the City of Greenville, S. C. and being designated as Lot No. 14 on the plat of Staunton Heights, as recorded in the RMC Office for Greenville County, S. C. in Plat Book RR, page 167 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Patti Drive, joint front corner of Lots 13 and 14 and running thence along the common line of said Lots S 13-0 W 224.1 feet to an iron pin; thence N 81-46 W 50.64 feet to an iron pin; thence N 82-49 W 29.6 feet to an iron pin, joint rear corner of Lots 14 and 15; thence along the common line of said Lots N 13-0 E 231.2 feet to an iron pin on Patti Drive; thence along said Drive S 77-0 E 80 feet to an iron pin, the point of beginning.
