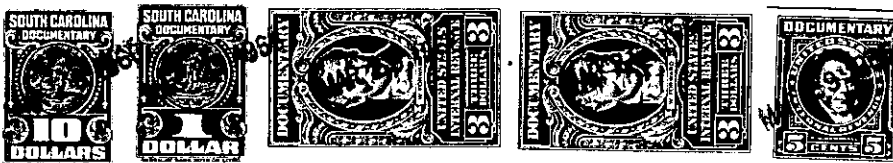
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

BEGINNING at a stake on the southern side of West Earle Street, three feet west of the northwestern corner of Lot 12 of Property of Mrs. Floride S. Miller as shown by plat of R. E. Dalton, recorded in Plat Book E at Page 99 (said stake being approximately 377 feet east from the eastern side of Rutherford Street and 718 feet west from the western side of Robinson Street) and running thence along Earle Street, S. 85-38 E. 66 feet to a stake; thence S. 2-46 W. 185.2 feet to a stake; thence N. 84-19 W. 64½ feet; thence N. 1-0E. 184½ feet, more or less, to the point of beginning.
