have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charles Houston Construction Inc., its assigns and successors, forever:

all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as lot No. 11 of a Subdivision known as Greenfields, Subdivision No. 2, as shown on a plat thereof recorded in the RMC office for Greenville County in Plat Book Y at page 34, and having according to said plat, the following metes and bounds, to-wit; BEGINNING at an iron pin on the eastern side of Gilman Avenue, joint front corner of Lots 10 and 11, and running thence along the joint line of said lots, North 73-33 East 130.7 feet to an iron pin; thence South 11-00 East 81 feet to an iron pin; thence South 75-03 West 125.3 feet to an iron pin on the eastern side of Gilman Avenue; thence with said Avenue North 14-47 West 85 feet to the beginning CORNER.
