in consideration of Five Hundred and no/100 (\$500.00)

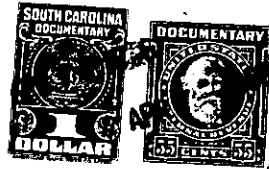

All that certain piece, parcel or lot of land situate, lying and being on the Southeastern side of Crosby Circle, Gantt Township, Greenville County, South Carolina, being shown as Lot 76 on Plat of Paramount Park, made by Piedmont Engineering Service, July, 1949, recorded in the R. M. C. Office for Greenville County in Plat Book W at Page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 75 and 76 on Crosby Circle, Gantt Township, Greenville County, South Carolina, and running thence along the common line of said lots S. 43-45 E. 113.1 feet to an iron pin on branch; thence S. 43-18 W. 100.2 feet to an iron pin on branch at the joint rear corner of Lots 76 and 77; thence along the common line of Lots 76 and 77 N. 43-45 W. 119.1 feet to an iron pin on Crosby Circle; thence along Crosby Circle N. 46-45 E. 100 feet to the point of beginning.
