Hilbert E. Wiggins and Ruby Wiggins, their heirs and assigns, forever:

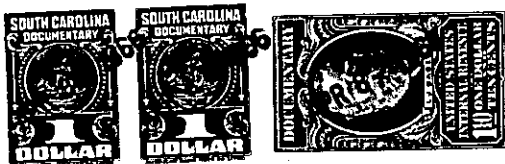
