release unto **E. Alfred . . Vaughn**, his heirs and assigns forever:

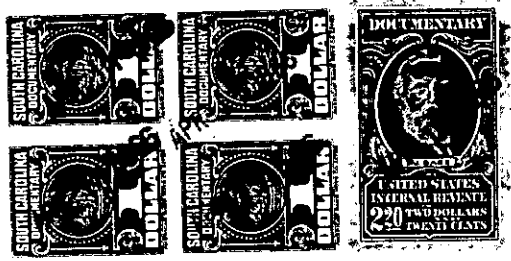
