ALL waterlines, mains, valves, hydrants, and appurtenances installed and located in, under, or along Live Oak Way and Live Oak Court, in Greenville County, South Carolina, being 1335' of 6" C. I. Pipe, 200' of 2" Galv. Pipe, 3 - 6" valves, 2 - 2" valves and 1 - Fire Hydrant. All as shown on drawing entitled "E. F. Cunningham and Rose Cunningham to City of Greenville", attached hereto and made a part of this conveyance.

TOGETHER with all pipes, valves, and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines and appurtenant equipment.
