All my undivided interest in and to all that certain tract of land in Paris Mountain Township, Greenville County, State of South Carolina, shown on plat recorded in Plat Book PP at page 47, being also shown as Lot 15, Block 1, page B.6 on the County Block Book, containing 6 acres more or less and being more particularly described as follows:

BEGINNING at an iron pin at the Southeastern corner of the lot now or formerly owned by Leroy Campbell and running thence with the line of the tract owned jointly by Clyde A. Walker and Mary W. Robinson, S. 84-30 E. 1396 feet, more or less, to pin; thence N. 20-30 E. 56.1 feet to a pin; thence N. 62 W. 474.7 feet to a pin; thence N. 84-30 W. 884 feet to a pin; thence S. 29-15 W. 240.9 feet to the point of beginning.
