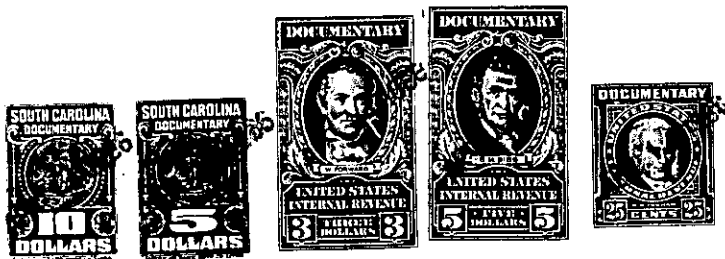
ALL that lot of land in Greenville County, South Carolina, known and designated as Lot Number Eleven (11) of Section Two (2) Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in plat Book "JJJ" at page 71; and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northeast side of Seven Oaks Drive at the joint front corners of Lots 12 and 11 and running thence along said lot lines N 43-03 E 187 feet to an iron pin; thence turning and running S 39-25 E 125 feet to an iron pin at the joint rear corners of lots 10 and 11; thence turning and running along said lot lines S 42-41 W 170 feet to an iron pin; thence turning and running along Seven Oaks Drive N 47 - 19 W 118.8 feet to an iron pin; thence continuing along Seven Oaks Drive N 46-0 W.6.2 feet to the point of beginning.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R. M. C. Office for Greenville County in Vol 784 at page 329.

This is a portion of the property conveyed to Audubon Forest, Inc., by F. H. Earle by deed recorded in said R. M. C. Office in Vol. 700 at page 383. The name of Audubon Forest, Inc., was changed to Chanticleer, Inc., by instrument recorded in said R. M. C. Office in Vol. 712 at page 481.
