in consideration of SEVEN THOUSAND FIVE HUNDRED AND NO/100----- Dollars,

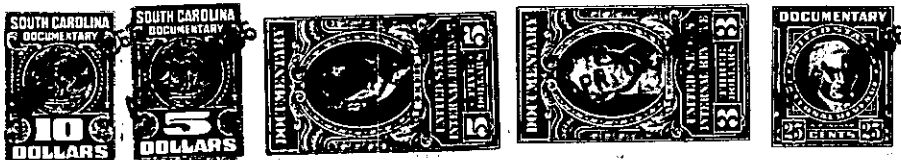

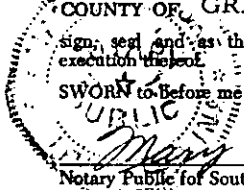

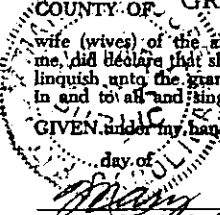
