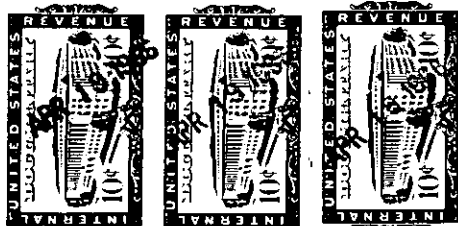
in consideration of Seven Thousand Nine Hundred Seventy Five and No/100-----Dollars,
