KNOW ALL MEN BY THESE PRESENTS, that we, Joseph M. Shipp, Jr. and Anna R. Shipp

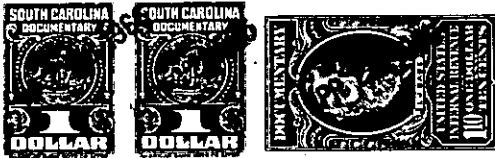

Book 559, page 85 the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

CECIL D. BUCHANAN, his heirs and assigns forever,

ALL that piece, parcel or lot of land with buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, located on the Southeast side of Crosby Circle, near the City of Greenville and shown as LOT NO. 126 on plat of Paramount Park, made by Piedmont Engineering Service, July 1949, recorded in the RMC Office for Greenville County in Plat Book W, at page 57 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the Southeast side of Crosby Circle at the joint front of Lots Nos. 125 and 126 and running thence with the line of Lot No. 125, South 63-49 East 264.2 feet to an iron pin; thence South 64-0 West 145 feet to an iron pin; thence with the line of Lot No. 127, North 51-06 West 192.9 feet to an iron pin on the Southeast side of Crosby Circle; thence along the curve of Crosby Circle (the chord of which is North 37-27 East 64.1 feet) to the beginning corner.

This being the same property conveyed to the Grantors herein by deed of Chester A. Réece, dated June 29, 1956 and recorded in the RMC Office for Greenville County in Deed Book 556, at page 139.
