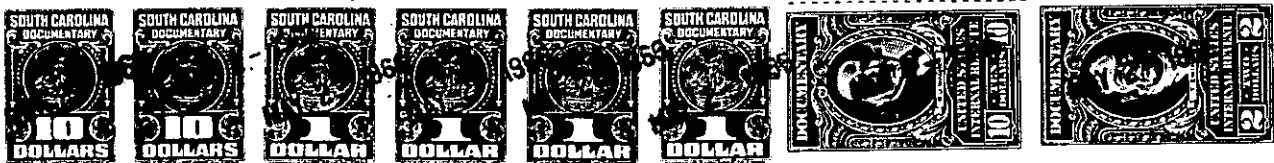
KNOW ALL MEN BY THESE PRESENTS, that we, Charles C. Dorn and Virginia J. Dorn,

in consideration of Eleven Thousand Nine Hundred Fifty and No/100----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
Dianne F. Bryant, her heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the northeastern side of Miracle Drive and being known and designated as Lot No. 142 on plat of Section 2 of Fresh Meadow Farms which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "NN", at Page 85 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Miracle Drive, joint front corner of Lots Nos. 142 and 143 and running thence with the common line of said lots N. 46-00 E., 184.7 feet to an iron pin; thence across the rear line of Lot No. 142 S. 47-55 E., 63.6 feet to an iron pin; thence with the common line of Lots Nos. 141 and 142 S. 41-23 W., 176.8 feet to an iron pin on the northeastern side of Miracle Drive; thence with said Drive the following metes and bounds, to-wit: N. 67-15 W., 29.2 feet to an iron pin; thence continuing N. 44-00 W., 50.7 feet to an iron pin, the point of beginning.
