

KNOW ALL MEN BY THESE PRESENTS That I, William J. Woodson, of the County of Greenville,

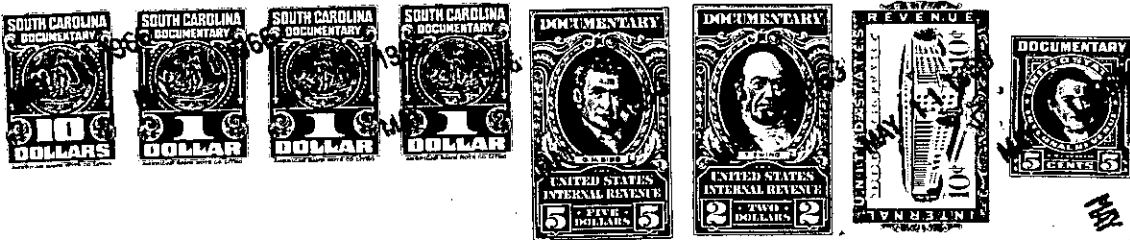
