KNOW ALL MEN BY THESE PRESENTS, that I, AZILEE RICHARDS MAYFIELD, formerly known as Azilee Richards

in consideration of One Dollar and correction of a prior deed Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM H. NORRIS AND EUNICE P. NORRIS, their heirs and assigns forever

All those two lots of land in the State of South Carolina, County of Greenville, being known and designated as Lot 15 and 16 on a plat of the D. N. Mayfield Estate, recorded in Plat Book CC at Page 199, and having such metes and bounds as shown on said plat. The Grantor herein took title to said lots by a deed recorded in Deed Book 467 at Page 422, wherein she was designated as Azille Richards. Then, in October, 1963, Grantor conveyed the lots to Grantee's predecesor in title, Pearl King, as Azilee Richards Mayfield by deed recorded in Deed Book 742 at Page 79. The purpose of this deed is to insure that the conveyance of these lots by Grantor will be properly indexed under the name in which she took title.
