

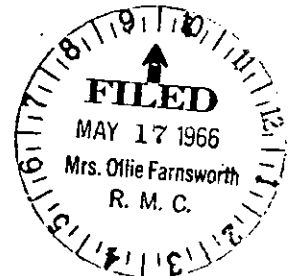
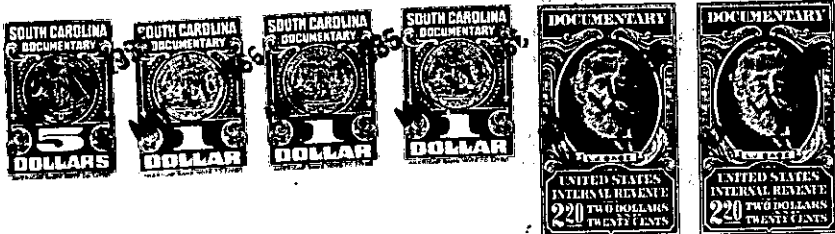

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John C. Jarrard, his heirs and assigns forever;

ALL that piece, parcel of land situate, lying and being in the town of Marietta, Bates Township, County of Greenville, State of South Carolina known and being a part of the R. Mays Cleveland Estate, also being identified by a plat and survey made by Jones Engineering Services of Greenville, S. C. Plat dated April 23, 1966 and showing said property as being on the North side of Elliott Street with the following metes and bounds to wit:

BEGINNING on an iron pin near a power pole on the North side of X Elliott Street and running thence; N. 17-30 E. 187.1 feet to an iron pin; thence S.80-50W. 455 feet to an iron pin on the Eastern side of Kathryn Street; thence with Eastern side of Kathryn St. S. 13-15 W. 151.8 feet to an iron pin in intersection of Elliott and Kathryn Street; thence with the Northern side of Elliott St. 433 feet to the beginning corner, said course being N. 83-15 E. with Elliott St., more or less.
