ALL water lines, mains, valves and appurtenances installed and located in, under or along Cox Drive, Paris View Drive in Paris View Heights Subdivision in the Town of Travelers Rest, Greenville County, South Carolina, being 4185' of 2" Galv. Pipe, and 4 - 2" valves, all as shown on drawing entitled "L. H. Tankersley to City of Greenville," attached hereto and made a part of this conveyance.
