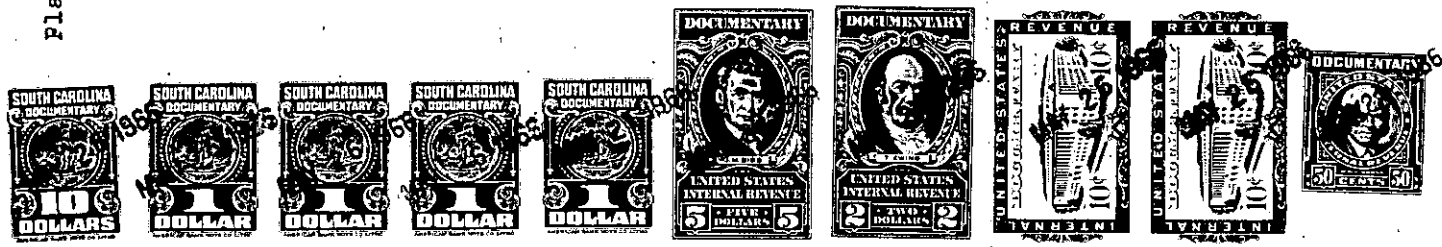

MANN in the State aforesaid, in consideration of the sum of SIX THOUSAND FIVE HUNDRED TEN AND NO/100 (\$6,510.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, ITS SUCCESSORS AND ASSIGNS FOREVER:

ALL water lines, mains, valves, sleeves, hydrants, and appurtenances installed and located in, under or along Old Indian Trail, Cree Court, Choctaw Court, and Belleview Drive, in Greenville County, State of South Carolina, being 1142' of 2" Pipe, 1420' of 6" Pipe, 1360' of 8" pipe, 3 - Fire Hydrants, 6 - 2" Valves, 4 - 6" Valves, 1 - 8" x 6" Tapping Sleeve and 6" Valve, all as shown on drawing entitled "Virginia B. Mann to City of Greenville", attached hereto and made a part of this conveyance.

TOGETHER WITH all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines and appurtenant equipment.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors Heirs and Assigns forever.
