the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Charles L. Stowe, his heirs and assigns forever;

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot #84 of a subdivision known as Wellington Green as shown on plat thereof prepared by Piedmont Engineering Service, dated September 1961, recorded in the R. M. C. Office for Greenville County in Plat Book "YY" at Page 29, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the eastern side of Rollinggreen Road, the joint front corner of Lots # 84 and #83, and running thence along the line of these lots, S. 59-30 E. 180.0 feet to an iron pin; thence N. 2-25 W. 110.5 feet to an iron pin at the joint corner of Lots #84, #85, and #86; thence N. 56-00 W. 120.0 feet to an iron pin on the eastern side of Rollinggreen Road; thence along the eastern edge of Rollinggreen Road, S. 30-30 W. 100.0 feet to an iron pin, point of beginning; being the same property conveyed by M. E. Howell to us by deed dated February 25, 1963, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 717, at Page 344.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s) or on the premises.

The grantee herein assumes and agrees to pay that certain note and mortgage heretofore execution unto First Federal Savings and Loan Association, which mortgage is recorded in the R. M. C. Office for Greenville County, and has a balance of \$20,597.04.
