All that certain piece, parcel or lot of land, lying and being on the northwesterly side of East Augusta Place, in the City of Greenville, S. C., being known and designated as Lot No. 14 on Map of Augusta Place, as recorded in the RMC Office for Greenville County, S. C. in Plat Book F, at page 128 and having according to a more recent survey prepared by R. K. Campbell, dated February 4, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of East Augusta Place, said pin being the joint front corner of Lots 14 and 15 and running thence with the northwesterly side of East Augusta Place S 58-30 W 60.23 feet to an iron pin, the joint front corner of Lots 13 and 14; thence with the common line of said Lots N 26-30 W 223.1 feet to an iron pin, the joint rear corner of Lots 13 and 14; thence N 63-30 E 60 feet to an iron pin, the joint rear corner of Lots 14 and 15; thence with the common line of said Lots S 26-30 E 212.3 feet to an iron pin on the northwesterly side of East Augusta Place, the point of beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

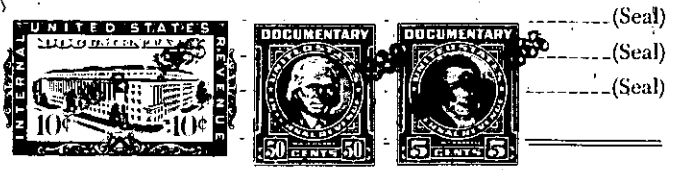
