ALL that certain piece, parcel or lot of land, with the improvements thereon, situate on the Northeast side of Rock Hill Road at the intersection with Theresa Drive, near the City of Greenville, in Greenville County, S. C., being shown as Lot no. 17 on a Plat of Dreher Colony, made by R. K. Campbell, Surveyor, January, 1964, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book FFF, Page 41, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northeast side of Rock Hill Road at joint front corner with lot now owned by Herbert A. Blassengale, Jr., and running thence along the line of said Lot S. 54-29 E. 120 feet to an iron pin; thence N. 53-29 W. 60.3 feet to an iron pin; thence N. 61-55 E. 74 Feet to an iron pin at the back corner of Lot No. 15; thence S. 28-05 E. 130.2 feet along the line of Lot No. 15 to an iron pin on Theresa Drive; thence S. 61-55 W. 20 feet to an iron pin; thence S. 40-10 W. 74.2 feet along Theresa Drive to an iron pin; thence S. 80-50 W. 37.8 feet along a chord to an iron pin on Rock Hill Road; thence N. 58-30 W. 85 feet along Rock Hill Road to an iron pin, the beginning corner.

THIS lot is conveyed subject to the restrictive covenants applicable to Dreher Colony as recorded in Deed Volume 716, page 157 in the Office of the R. M. C. for Greenville County and all easements and rights of ways of record as shown on the above described plat.
